

# International Contestant Requirements and Petition For the International Person of Leather Contest

#### Basic Philosophy for the International Person of Leather Contest and Titles

International Person of Leather will be selected not based on gender identity, sexual orientation, race, physical appearance, age, or disability, but rather on their ability to articulate their views, passions, and dedications and to make an impact in their communities. We will expect these People of Leather to act as mentors, educators, role models and spokespeople throughout their title year. The International Person of Leather Contest is a celebration of the diversity in the Leather community. The title of Person of Leather exists to promote that diversity.

<u>Eligibility of International Contestants to Compete at the International Person of Leather Contest</u> International invites and encourages contestants from outside of the United States ("international contestants") pursuant to the following rules and policies:

- 1. The decision to accept any international contestant by Petition to compete at the International Person of Leather Contest ("International") in any given year is completely within the discretion and control of the Owner/Producer of International.
- 2. All contestants competing in the International Person of Leather Contest must be at least 21 years of age, self-identify as part of the Leather Community and have participated in the Leather Community for at least five years prior to competing for the International Person of Leather title.

#### **Amending the Policies and Requirements**

1. International reserves the right to amend these Policies and Requirements.

#### **Process of Petitioning to International**

1. All contestants who live outside of the United States may petition directly to International to compete in the International Person of Leather Contest.

Contestants in the Countries of Canada or Mexico have an additional option to obtain eligibility to compete at the International Person of Leather Contest.

Contestants who live in <u>Canada or Mexico</u> may either petition International directly to compete or choose to compete at a United States Regional Feeder Contest as follows:

- British Columbia and Alberta may choose to run in the IPOL Northwest Region.
- Saskatchewan, Manitoba, north of Manitoba, Yukon and the Territories may choose to run in the IPOL Rocky Mountain Region.
- Ontario and east of Ontario may choose to run in the IPOL Northeast Region.

Contestants who live in Mexico may either petition International directly to compete in the International POL Contest or if they desire support from a U.S. Regional Contest and Organization, they may compete in and win the U.S. Southeast Regional contest.

An international contestant is not required to go through a contest or other selection process in order to submit a Petition to Compete at International. However, it is the opinion of the Owner/Producer of International that going through a contest process similar to the process used at International is helpful to the contestant as part of their preparation to run for the International title.

- 2. The international contestant must submit an International Contestant Petition to Compete ("Petition") no later than October 31st prior to the International Contest however in any given year, an international contestant may be accepted prior to October 31st. (For example, an international contestant wishing to compete at International 2025 would need to submit a Petition no later than October 31, 2024.) International contestants who petition to compete will be notified of International's decision on their Petitions no later than November 15..
- 3. If an international contestant's Petition is accepted, the contestant will be required to follow the same International rules as a Regional contestants, including submitting the formal IPOL Contestant Application. All contestants will be judged according to the IPOL Judges' Handbook and will be subject to the rules and requirements found in the Judges' Handbook, the IPOL Contest Application, the IPOL Contest Handbook and the IPOL Contest Regional Handbook. - 4. An international contestant must agree that during the time period between the date they submit their petition to International and the date of the International Person of Leather Contest, they will not engage in interviews with or appear in "vanilla" mainstream media (whether print, television, film, radio or internet based) without the express written consent of the Owner/Producer of the International Person of Leather Contest.

- 5. If the Petition of an international contestant is not accepted by International, they may re-petition International for the opportunity to compete the following year. An international contestant may not petition to compete at International more than two (2) times.
- 6. If the Petition of an international contestant is accepted by International but the contestant does not win at International, they may re-petition International for the opportunity to compete in a future year. An international contestant may not petition to compete at International more than two (2) times.
- 7. If an international contestant competes and wins the International contest they are not eligible to petition or to compete at International in any subsequent year.
- 8. It will be the responsibility of an international contestant competing at International to obtain all travel documents, visas, clearances, etc. needed in order to enter the United States. Because of the privacy sensitivities and issues that still impact the Kink and Leather community in the U.S., an international contestant should not highlight the International contest or South Plains Leatherfest as the reason for entering the country.
- 9. The official language of the International contest is English. If a contestant believes they need an interpreter to effectively compete at International, they may bring one at their own expense. South Plains Leatherfest will provide the interpret with a basic weekend package.
- 10. Prior to submitting a Petition, an international contestant should carefully read the IPOL Judges' Handbook, the IPOL Handbook and the formal IPOL Contestant Application, all of which are available at the South Plains website (www.southplainsleatherfest.com).
- 11. If an international contestant wins International, the titleholder will be expected to meet the requirements for the title as stated in the Contestant Application. The titleholders are required to attend a minimum number of events each year; these events do not have to be in the United States.
